The capital stock of this corporation shall be divided into 100 shares of common stock of \$1.00 par value.

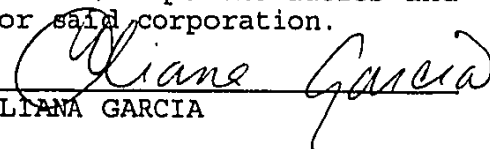
