#### Article 1 - Name

The name of this professional service corporation is Backer Law Firm, Professional Association

#### Article 2 - Duration

This corporation shall exist perpetually commencing on the date of the filing of these Articles of Incorporation with the Department of State.

#### Article 3 - Purpose

The professional service corporation is formed to engage in every phase and aspect of the practice of law. #### Article 9 - Restraint on Alienation of Shares

The shareholders of the professional service corporation shall have the power to include in the bylaws, or by separate agreement adopted by a majority of the shareholders of the professional service corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer, or other disposition of any of the outstanding stock of the professional service corporation by any of its shareholders, or in the event of the death of any of its shareholders. after it has been approved at a shareholder meeting especially called for that purpose. If any shareholder becomes legally disqualified to practice law in the State of Florida, is elected to a public office, or accepts employment that places restrictions or limitations on the continuous rendering of such professional services, that shareholder's shares of stock shall immediately become subject to purchase by the professional service corporation in accordance with the bylaws adopted by the shareholders.

#### Article 10 - Amendment

This corporation reserves the right to amend or repeal any provisions in these articles of incorporation, or any amendment hereto, in the manner provided by law. Any right conferred upon the shareholders is subject to this reservation.
