ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME AND PRINCIPAL OFFICE

The name of this corporation is LINDO CAFE, INC., and its principal office is located at 209 West Strong Street, Pensacola, Florida 32501, and its mailing address is the same.

ARTICLE II

DURATION
