The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation is **CarriAir Express, Inc.**

The maximum number of shares of stock which the corporation is authorized to issue and have outstanding at any one time is 10,000 Class A voting common shares having a par value of \$.01 per share.
