ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is SKRKO, Inc., and the principal address is 9311 Forrester Drive, Bradenton, FL, 34202.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is Mason & Associates, P.A., 17757 U.S. Highway 19 North, Suite 500, Clearwater, FL 34624. The name of its registered agent at such address is Joseph C. Mason, Jr.

ARTICLE III - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the General Corporation Law of the State of Florida.
