

Article I be and it hereby is amended to read as follows:


"The name of this corporation shall be: SCOGGINS CHEVROLET OLDS-BUICK, INC."

2. The foregoing amendments were adopted by the Stockholders and Directors of the corporation on the 4<sup>th</sup> day of July, 1997.


