THE UNDERSIGNED acting as the sole incorporator of a corporation to be formed under the Florida General Corporation Act, adopts the following Articles of Incorporation:

FIRST: The name of the Corporation (the "Corporation") is CONTRACTORS ONLY CLEANING COMPANY, INC.

<u>SECOND</u>: The purpose or purposes for which the Corporation is organized are:


