ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF PARK SHORE PROPERTIES, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is PARK SHORE PROPERTIES, INC.
- 2. The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on the $\underline{24th}$ day of \underline{March} , $\underline{1997}$ in the manner prescribed by the Florida General Corporation Act:
