This is in response to your request for confirmation of your exemption from Federal income tax.

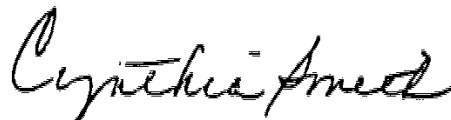
