Enclosed please find an Application for Reinstatement, as we have been notified that our corporation has been administratively dissolved effective August 23, 1996. We respectfully request that the reinstatement fee of \$585 be waived. Our corporation has filed timely from 1987 through 1995. Our internal procedures have not changed from 1987 to present.

Without a doubt, the 3 partners of Hamilton Taylor & Griffith, P.A. agree that we did not receive the Annual Report in January of 1996. Since our corporation was dissolved in 1996, we did not receive the Annual Report in January 1997. This is a CPA firm, and we do not ignore important matters and documents such as an Annual Report. Our address has not changed since 1989, and we have received Annual Reports at this address for numerous years. Also, we are accustomed to seeing our client's Annual Reports, second notices, and sometimes dissolution notices. We saw none of these last year for our corporation. It does not matter if the mail is opened and placed on any of the 3 partner's desks, it would still obtain the highest priority to accomplish the filing. All 3 of the partners are unanimous and adamant that none of the 3 reports were received in 1996.

Inasmuch as we are positive that we never received the Annual Report, we are requesting waiver of the \$585 reinstatement fee. Enclosed herewith please find a check in the amount of \$338.75 for payment of the 1996 and 1997 Annual Reports, and a Certificate of Status.
