To whom it may concern:

Enclosed please find an Application For Reinstatement for QWS, Inc. and Option Trend Resources, Inc.. Both corporations are currently dissolved due to the Annual Report not being filed. I was made aware of this when I called with some questions about filling out an application for a Fictitious Name for QWS. I spoke to a gentleman named Tom who told me that the corporation was dissolved because the Annual Report had not been filed for QWS, Inc. within the needed time period. I requested that he check the status of Option Trend Resources of Pinellas, Inc. and the exact same situation existed. I explained to him that I had never received forms or notices for either corporation and was unfamiliar with the process, as this was our first year in business.

Tom checked the mailing addresses on both corporations and they were both listed incorrectly. Our mailing address should be 14433 90th Ave. N. and both were on your records as 1443 90th Ave. N., which is apparently where the Annual Reports and all other notices were sent, thus never reaching us. We received no communication at all regarding this, and as I stated, we just happened to find out about it while dealing with another matter.

We are requesting that an exception be made in this case regarding reinstatement and penalty fees. We are completely unable financially to pay the high penalty amounts normally charged for reinstatement. Option Trend Resources is a one person company with annual sales of under \$15,000, and the \$750.00 reinstatement fee represents almost a 6 month profit for this particular company. QWS is also a small company with only one employee and would be very hard pressed financially to pay the reinstatement fee or to begin the incorporation process again as that is also costly.




