## ARTICLES OF INCORPORATION

### MARY'S GOLDEN CASTLES, INC.

ARTICLE I

**NAME** 

The name of the Corporation is:

MARY'S GOLDEN CASTLES, INC.

ARTICLE II

**DURATION** 

The Corporation shall exist in perpetuity.

ARTICLE III

**PURPOSE** 

The Corporation is organized for the purpose of transacting any or all lawful business.
