

**ARTICLES OF AMENDMENT TO THE  
ARTICLES OF INCORPORATION OF  
OXFORD RIDGE, INC.**

1. Pursuant to Sections 607.1005 and 607.1006, Florida Statute, OXFORD RIDGE, INC. hereby adopts the following Articles of Amendment to its Articles of Incorporation:

A. Article I is amended to provide that the name of the corporation shall be **YARDARM DEVELOPMENT, INC.**


2. The Amendment does not provide for an exchange, reclassification, or cancellation of issued shares.


