AMENDMENT TO ARTICLES OF INCORPORATION OF THE FRENCH AMERICAN CHAMBER OF MIAMI / FT. LAUDERDALE, INC.

Pursuant to the provisions of the Florida Not For Profit Corporation Act, Sections 617.1001 and 617.1002 Florida Statutes, and pursuant to the provisions of Article XII of its Articles of Incorporation, the FRENCH AMERICAN CHAMBER OF COMMERCE OF MIAMI / FT. LAUDERDALE, INC., at its annual meeting held on November 3, 1997, at Miami, Dade County, Florida, upon recommendation of the officers and directors [made upon a two-third (%) vote of the officers and directors at a Board of Directors Meeting held October 6, 1997], with a quorum present and by unanimous vote of the members, herewith adopts the following Amendment to the first paragraph of Article X, Paragraph A, of its Articles of Incorporation:

Α. The Board of Directors shall have general management of the corporation and shall consist of not less than three (3) and not more than twenty (20) directors. the exact number to be fixed by the By-Laws. The members of the corporation shall elect a maximum of fifteen (15) members of the Board of Directors; and the President, subject to the approval of the entire Board of Directors, may appoint a maximum of five (5) additional members of the Board of Directors, provided, however, that the total number of appointed members of the Board of Directors shall never exceed one-third (1/3) of the total number of members of the Board of Directors. Members of the Board of Directors who are appointed shall serve until the next General Election of the members of the corporation."
