INCORPORATION OF TABAS, SINGERMAN & FREEDMAN, P.A.**

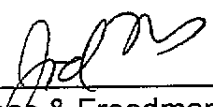
In accordance with the provisions of Section 607.1006 of the Florida General Corporation Act, the undersigned corporation hereby adopts the following:

2. The amendment to the articles of incorporation were adopted at a

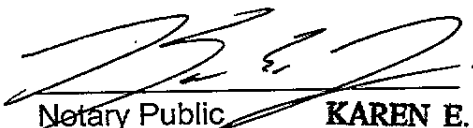
meeting of directors on February 17, 1998 in the matter prescribed by the Florida General Corporation Act.
