KNOW ALL MEN BY THESE PRESENTS, That the Declaration of Trust of LAWYERS' TITLE GUARANTY FUND, filed with the Secretary of State of Florida, March 22, 1947, as amended by amendments filed with the Secretary of State of Florida on April 26, 1950, February 15, 1951, April 5, 1951 and June 3, 1955, be and is hereby further amended as follows:

AMENDMENT XIV

Section 26 of the Declaration of Trust as it is shown after the last previous amendment to said Declaration filed with the Secretary of State on June 3, 1955, is amended by adding to said Section a paragraph (c) reading as follows:

- (c) The Board of Trustees also may allocate and use an amount, not to exceed ten (10%) percent of The Fund's assets, for purchase of stock of Lawyers' Title Services, Inc.
