The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

The name of the corporation is Rhonda J. Fisher, P.A.

**ARTICLE II**

The term of existence of the corporation is perpetual.

**ARTICLE III**

The purpose for which the corporation is the practice of the profession of law.


**ARTICLE VII**


