ARTICLES OF INCORPORATION

OF

I, the undersigned, being desirous of forming a corporation under the Laws of the State of Florida, declare:

ARTICLE I

NAME

The name of this Corporation shall be:

AUTHORIZED SHARES

ARTICLE IV


REGISTERED OFFICE AND AGENT

ARTICLES VIII


INDEMNIFICATION

The foregoing right of indemnification shall be in addition to and not exclusive off all other rights to which such director or officer may be entitled.


ARTICLE IX
