# <u> ARTICLE I - NAME</u>

The name of this corporation is: EXPO-AIRE, INC.

#### ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incorporation by the initial subscribers.
