**ARTICLES OF AMENDMENT TO  
THE ARTICLES OF INCORPORATION OF  
SORRENTO VILLAS, SECTION 6, CONDOMINIUM  
ASSOCIATION, INC.**

KNOW ALL MEN BY THESE PRESENTS:

The Unit Owners/Members of SORRENTO VILLAS, SECTION 6, CONDOMINIUM ASSOCIATION, INC., a Florida not-for-profit corporation organized under Chapters 617 and 718 of the Florida Statutes, and being the entity responsible for the operation of SORRENTO VILLAS, SECTION 6, CONDOMINIUM, situated in Nokomis, Sarasota County, Florida, in accordance with the Declaration of Condominium recorded in Official Records Book 1028, Page 1395, et seq., of the Public Records of Sarasota County, Florida, have adopted an amendment to the Articles of Incorporation as described hereinbelow:

1. The name of the Corporation is SORRENTO VILLAS, SECTION 6, CONDOMINIUM ASSOCIATION, INC.

2. ARTICLE 9 OF THE ARTICLES OF INCORPORATION, ENTITLED "AMENDMENTS", at Section 9.1, "AMENDMENTS", at Subsection (b) thereof, is hereby amended as follows:

- (b) A resolution for the adoption of a proposed amendment may be proposed either by the board of directors or by the members of the Association. Except as elsewhere provided, such approvals must be by not less than seventy-five percent (75%) a majority of the entire membership of the board of directors and by not less than seventy-five percent (75%) two-thirds (2/3) of the votes of the entire membership at a duly called and convened Association meeting; or by not less than eighty percent (80%) of the votes of the entire membership of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary at or prior to the meeting.

**KEY: Words underlined are additions to the existing Articles of Incorporation.**  
**Words in shading are deletions to the existing Articles of Incorporation.**

3. The foregoing amendment was adopted by the members at a special meeting of the Corporation on March 19, 1998, at which meeting a quorum was present, and the amendment was approved by a sufficient number of votes cast by the members, being 49 in favor, none opposed and one abstention; said meeting having been called, in part, for the purpose of considering the foregoing amendment to the Articles of Incorporation.

4. Such action was taken subsequent to a meeting of the Board of Directors, who, by a unanimous vote, adopted a similar resolution in support of the foregoing amendment.

EXECUTED this 5<sup>th</sup> day of May, 1998, in the name of the Corporation by its President and its Secretary, who declare under the penalties of perjury that the facts stated herein are true.
