



ARTICLE I - NAME

This corporation shall be known as Sharon L. Gasparo, P.A.

ARTICLE II - PURPOSE

The purpose for which this corporation shall exist is to engage in the practice of law as permitted under the laws of the United States of America and the State of Florida.

ARTICLE III - TERM OF EXISTENCE

The term for which this corporation shall exist is to be perpetual.

ARTICLE IV - CAPITAL

The amount of capital for which this corporation shall commence business is \$1,000.00.

ARTICLE V - STOCK

The total number of shares of capital stock which may be issued by this corporation is 100 shares, each share having a nominal par value of \$10.00 per share, all of which shall be common stock and shall be fully paid and non-assessable.


ARTICLE X - AMENDMENT


