The undersigned, acting as incorporator of **CREATIVE COMPUTER CORPORATION** under the Florida Business Corporation Act, adopts the following articles of incorporation.

ARTICLE I - NAME

ARTICLE III - COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing these articles of incorporation.

ARTICLE IV - PURPOSE

ARTICLE V - AUTHORIZED SHARES


ARTICLE IX - BYLAWS

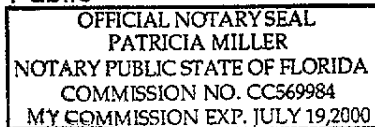
