**ARTICLES OF AMENDMENT TO**  
**ARTICLES OF ORGANIZATION OF 1920 PARTNERS L.C.**

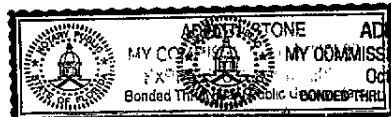
