### ARTICLES OF AMENDMENT

# TO THE ARTICLES OF INCORPORATION

OF

## CREATIVE HOMES OF AMERICA, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, the Articles of Incorporation of the above named corporation (the "Corporation"), filed with the Department of State on April 27, 1998, and assigned document #P98000038703, are hereby amended, pursuant to approval by the holders of all of the corporation's Common Stock, as follows:

1. Article III is hereby amended to read as follows:

### ARTICLE III

The aggregate number of shares that the corporation shall have authority to issue and to have outstanding at any one time is 10,000 shares. All such shares shall be of a single class, designated as common and having a par value of \$.10 per share.
