The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, do hereby adopt the following articles of incorporation:

#### ARTICLE I - Name

The name of the corporation is B & G Gas Appliance Service & Installation, Inc.

#### ARTICLE II - Principal Office and Mailing Address of the Corporation
