ARTICLES OF INCORPORATION

FOR

THE UNDERSIGNED, FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE
FLORIDA GENERAL CORPORATION ACT DO HEREBY ADOPT THE FOLLOWING ARTICLES
OF INCORPORATION:

ARTICLES ONE

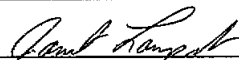
