- 6. <u>Mailing Address.</u> The mailing address of the Limited Partnership is 7023 Montrico

- 7. Term. The Partnership shall begin at the time of the filing of the certificate of Limited Partnership with the Department of State and shall liquidate and dissolve on December 31, 2048, unless sooner dissolved by law or by agreement of the parties hereto or unless extended by a majority agreement of the Partners.
- 8. Additional Contributions. No additional contributions of the Limited Partners have been agreed upon.
- 9. Return of Contributions. No Limited Partner shall be entitled to withdraw or demand the return of any part of his or her capital contribution except upon dissolution of the Partnership.

- 14. Continuance of Business. Upon the death, retirement or incapacity of the surviving General Partner, the Partnership shall dissolve unless continued by the remaining Partners and

selecting when necessary, by unanimous vote, a new successor General Partner.

- Property Other than Cash. A Limited Partner may not demand property other than 15. cash in return for his or her contributions.
