# ARTICLES OF INCORPORATION OF CHRIS CASELLA CONSTRUCTION, INC.

The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the laws of the State of Florida.

#### ARTICLE I

The name of the corporation is CHRIS CASELLA CONSTRUCTION, INC.

#### ARTICLE II

The general purposes for which the corporation is organized are:

- 1. To engage in all phases of residential and commercial construction.
- 2. To do such other things as are incidental to the foregoing or necessary or desirable to accomplish the foregoing.
- 3. To transact any business for which corporations may be incorporated under the Florida General Corporation Act.
