I informed him that this was the first report that we had received for this company from your office, he informed me that it was an error from your office and to go ahead and send the report in with a check for \$150.00 which is what I have done. Now your office has returned the check and report asking for \$550.00. This is totally unacceptable.

If your office is not up-to-date on its reporting then I do not feel that the companies registered to do business in your state should be penalized for that. I am, therefore, complying
