

#### ARTICLES OF INCORPORATION

The undersigned hereby makes, subscribes, acknowledges and files these Articles of Incorporation for the purpose of forming a Corporation under the laws of the State of Florida.

# ARTICLE 1 - NAME

The name of this corporation is Serena Gerard Enterprises Arc.

#### ARTICLE 2 - DURATION

This corporation shall have perpetual existence.

# ARTICLE 3 - PURPOSE
