**AMENDMENT TO LIMITED PARTNERSHIP AGREEMENT OF WHARTON
INVESTMENT GROUP OF MARGATE, LTD.**

THIS AGREEMENT is made and entered into this 3rd day, of September, 1998, by and between Wharton Investment Group of Margate, Ltd. and Procacci Margate, Inc., a Florida Corporation, its General Partner.

The parties hereto for and in consideration of the sum of Ten Dollars (\$10.00) each to the other paid and receipt of which is acknowledged do hereby amend the Partnership Agreement dated the 11th day of June, 1997, as follows:

The parties hereto are desirous of amending the Partnership Agreement as follows:

Paragraph 1.08 Other Activities is hereby amended as follows:

1.08 Other Activities. The General Partner, or any Limited Partner, Affiliate (as hereinafter defined), employee, person or entity holding a legal or beneficial interest in the Partnership recognizes that this is a sole purpose entity for the purpose of holding title to real estate being mortgaged by the General Partner and that they may engage in no other business venture of any nature, type, or description and are strictly prohibited from doing so without any exception.

Paragraph 1.09 Interested Parties is hereby amended as follows:

1.09 Interested Parties. The General Partner nor the Limited Partner, or if in the future Partners, recognize that the purpose of this Limited Partnership is to create a sole purpose entity for mortgaging the Premises owned by this Partnership and neither the General Partner nor any Limited Partner or Partners, may engage in any other business venture of any nature or description including any real estate projects that in any way affect the nature and intent of this Partnership without any exclusions whatsoever.

Paragraph 7.02 Powers and Duties of the General Partner, (4), is hereby amended as follows:

(4) to finance the Partnership's activities by borrowing money from the Lender, all on such terms and conditions as the General Partner deems appropriate. In instances where money is borrowed for Partnership purposes, the General Partner shall be, and hereby is, authorized to pledge, mortgage, encumber and grant a security interest in Partnership properties for the repayment of such loans consistent with this Agreement.
