OF

The undersigned, as an authorized representative of a member of the Company, pursuant to Chapter 608, Florida Statutes, files the following Articles of Organization establishing a Florida limited liability company named Sensor Systems, L.L.C.

**ARTICLE I**

Name

The name of this limited liability company shall be SENSOR SYSTEMS, L.L.C. (the "Company").

### Right of Continuation


