**ARTICLES OF INCORPORATION  
OF

**ARTICLE I - NAME AND MAILING ADDRESS**

The name of this corporation is Cantonment One, Inc. and the mailing address of this corporation 516 Lakeview Road, Unit 8, Clearwater, FL 33756.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence.
