ARTICLES OF INCORPORATION

OF

ACCESS SOLUTIONS SERVICES,

For the purpose of forming a corporation under Ch.607 of the Florida General Corporation Act, it is respectfully requested of the Secretary of State the approval of such incorporation under the following Articles.

ARTICLE 1

The name of this corporation shall be ACCESS SOLUTIONS SERVICES, INCORPORATED principal place of business shall be in South Florida with the right to move said principal place of business and establish other places of business within or without the State of Florida as the Board of Directors may from time to time deem proper.
