## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

THE MATHEW FORBES ROMER FOUNDATION, INC., a Florida nonprofit Corporation



Pursuant to Section 617.1001, Florida Statutes, the Articles of Incorporation of the abovenamed Corporation are hereby amended as follows:

1. The Articles of Incorporation are hereby amended to add Article XVI, as follows:

## XVI - DISSOLUTION OF CORPORATE EXISTENCE

On dissolution, assets of this Corporation remaining after the payment or discharge of all Habilities of the Corporation; the return. transfer or conveyances of assets held on conditions requiring the same; and the transfer or conveyance of assets received and held subject to limitations permitting their use only for charitable. electrosynary, benevolent, educational or similar purposes shall be distributed to an organization or organizations organized and operated exclusively for charitable, educational or scientific purposes, as shall be at the time qualify as an exempt organization or organizations under Sec. 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law), as the Board of Directors shall determine. Any of such assets not disposed of shall be disposed of by the court having proper jurisdiction in the county where the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine. which are organized and operated exclusively for such purposes.

- The foregoing Amendment was adopted on September 9, 1998.
- 3. The number of votes cast for the Amendment by the Voting Members was sufficient for approval.


