**ARTICLE I-NAME**

The name of this corporation is Don Pybus and Company, Inc. Hereinafter Referred to as the "CORPORATION"

**ARTICLE II- DURATION:**

The CORPORATION shall exist perpetually, commencing upon the filing of the ARTICLES OF INCORPORATION with the Department of State.

**ARTICLE III-PURPOSE:**

The CORPORATION is organized for the purpose of engaging in the construction business and for the purpose of transacting any and all other lawful business not inconsistent with the Laws of the State of Florida.

**ARTICLE IV- CAPITAL STOCK:**

The CORPORATION is authorized to issue 1000 shares at one dollar (\$1.00) par Value common stock.

**ARTICLE V- PREMPTIVE RIGHTS:**

Every shareholder, upon the sale for cash of any new stock of the same kind, Class or series as that which he or she already holds, shall have right to purchase His or her pro-rata share thereof (as nearly as may be done with our issuance of fractional shares) at the price at which it is offered to others.

**ARTICLE VI- INITIAL REGISTERED OFFICE AND AGENT:**




**ARTICLE IX- BY LAWS**


