ARTICLE I





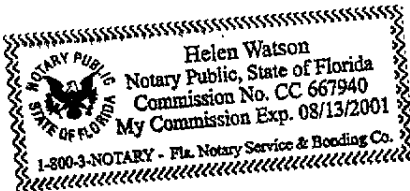
