

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be House and Homes Magazine, Inc.

ARTICLE II - PURPOSE OF CORPORATION

The purpose and activities of the corporation shall include, but not be limited to:

1. Sell advertising in real estate publications and/or electronic versions of same.
2. Any other lawful purpose.

ARTICLE III - PRINCIPAL OFFICE




