

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF TRC ADVISORY GROUP, INC. (reflecting name change to) GENERAL WASTE SOLUTIONS, INC.



- 1. The name of the corporation is GENERAL WASTE SOLUTIONS, INC.
- 2. An Amendment to Article I of the Articles of Incorporation of TRC Advisory Group, Inc. has been adopted by the directors and shareholders of this corporation pursuant to Sections 607.0821, 607.0704 and 607.1003, Florida Statutes (1997), to change the name of the corporation to GENERAL WASTE SOLUTIONS, INC. As amended, Article I, now reads:

"ARTICLE I

NAME

The name of the corporation is GENERAL WASTE SOLUTIONS, INC."

- 3. The above amendment to Article I of the Articles of Incorporation shall be effective as of the filing date.
- 4. The above amendment to Article I of the Articles of Incorporation was adopted by unanimous consent of all of the directors and shareholders entitled to vote, on October 21, 1998.
- 5. The only voting group entitled to vote on the adoption of the amendment consists of the holders of the corporation's common stock. The number of votes cast by such voting group was sufficient for approval by that voting group.
