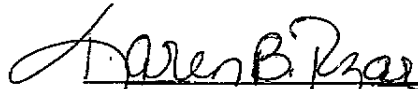

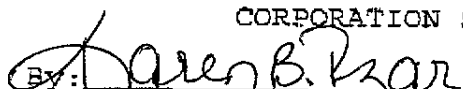

LIMITED POWER OF ATTORNEY
