

**ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation, **BUG MASTER DO-IT-YOURSELF PEST CONTROL, INC.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment (the "Amendment").

1. **First Amendment Adopted:** The Amendment adopted provides for a change in the corporate name as set forth in Article I of the Articles of Incorporation.
2. **Text of Amendment:** Article I of the Articles of Incorporation is amended by deleting such Article I in its entirety and substituting in lieu of such Article I the following Article I which reads as follows:


**ARTICLE I

4. **Effective Date:** The effective time and date of the Amendment is October 29, 1998.


