## ARTICLES OF AMENDMENT BUG MASTER DO-IT-YOURSELF PEST CONTROL, INC. TALLAHASSEE PLANT OF STATE TO THE ARTICLES OF INCORPORATION OF

FILED 98 NOV I O AM 10: 29

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation, BUG MASTER DO-IT-YOURSELF PEST CONTROL, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment (the "Amendment").

- First Amendment Adopted: The Amendment adopted provides for a change in the corporate name as set forth in Article I of the Articles of Incorporation.
- Text of Amendment: Article I of the Articles of Incorporation is amended by deleting such Article I in 2. its entirety and substituting in lieu of such Article I the following Article I which reads as follows:

## ARTICLE I Name

The name of the Corporation is THE BUG SHOPPE DO-IT-YOURSELF PEST CONTROL STORE, INC.

- Authorization of Amendment: The Amendment was unanimously adopted on October 29, 1998, pursuant to Section 607.1003 of the Act, by the Directors and Shareholders of the Corporation.
- Effective Date: The effective time and date of the Amendment is October 29, 1998.
