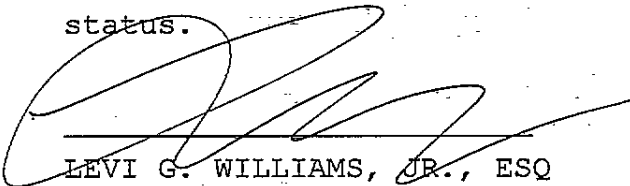
For the purpose of forming a stock corporation under the provisions of Chapter 607 of the Florida Statutes, I hereby set forth the following:

1. The name of the corporation is Knights of the Soundtable, Inc.
2. The corporation is organized for the purpose of engaging in the production; management; promotion; and to act as a record label in the entertainment industry.
3. The corporation shall also have the power to enter into partnership agreements with other corporations and individuals, and also to carry on business of any character whatsoever that is not prohibited by law or required to be stated in these Articles.
4. The aggregate number of shares the corporation shall have the authority to issue and the par value per share are as follows:
