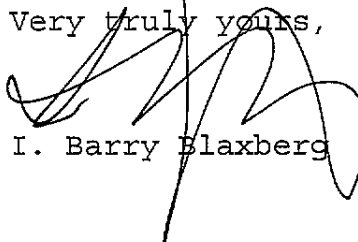

ARTICLE I.  
CORPORATE NAME

The name of this corporation shall be: ABOBLAX, INC.

The number of Directors may be altered from time to time by By-Laws adopted by the Stockholders. However, the Corporation shall have no less than one (1) Director at any time.

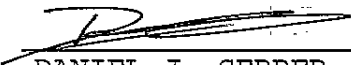
