
**SUPPLEMENTAL AFFIDAVIT OF CAPITAL CONTRIBUTION


Pursuant to the provisions of Section 620.112, Florida Statutes, the undersigned, being all of the General Partners of L. K. Family Limited Partnership, do hereby affirm and swear as follows:

1. The anticipated amount of the capital contributions of the Limited Partners of L. K. Family Limited Partnership as filed pursuant to Section 620.108, Florida Statutes, was One Million One Hundred Thousand Dollars (\$1,100,000).

2. The actual contributions of the Limited Partners of L. K. Family Limited Partnership exceeded the anticipated amount. The amount of capital contributions contributed by the Limited Partners of L. K. Family Limited Partnership was One Million Three Hundred Thirty Thousand Eight-three Dollars (\$1,330,083).
