The undersigned, acting as the incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

#### Article I Name

The name of the corporation shall be The Alachua Learning Center, Inc.

## Article II Principle Place of Business and Mailing Address

### Article III Purposes

The specific purposes for which the corporation is organized are:

To establish and operate a not for profit charter school;

To engage in any activity and exercise any power or authority that may be engaged in by a non-profit corporation organized under Chapter 617, Florida Statutes, as amended.

## Article IV Manner of Election of Directors

The manner is which the directors are elected or appointed shall be stated in the by-laws of the corporation.

## Article V Limitation of Corporate Powers

The corporate powers of this corporation are as provided in Section 617.0302, Florida Statutes, unless limited as follows:

- (a) This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b) The corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible Section 170(c)(2) of the Internal Revenue Code.
- (c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.
