ARTICLES OF INCORPORATION OF, SPRINGS RIVER FESTIVAL, INC.

BY THESE ARTICLES OF INCORPORATION the incorporators form a corporation not-for-profit under Florida Statutes, Chapter 617,

ARTICLE I. NAME / REGISTERED OFFICE

The name of this corporation is SPRINGS RIVER FESTIVAL, INC., The corporations' principal office and mailing address shall be located at: 166 Hialeah Drive, Hialeah, Florida 33010.

ARTICLE II. PURPOSE

This corporation is formed for the purpose of producing the annual Springs River Festival and for other civic or charitable purposes.

No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under §170(c)(2) of the Internal Revenue Code or the corresponding provision of any future United States internal revenue law. On the dissolution of this corporation the board of directors shall dispose of all of the assets of this corporation exclusively for the purposes of this corporation in the manner or to the organization or organizations that are organized and operated exclusively for charitable, educational, religious or scientific purposes and that shall at the time qualify as exempt organizations under §501(c)(3) of the Internal Revenue Code or the corresponding provision of any future United States internal revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purposes to the organizations that the court determines are organized and operated exclusively for charitable, educational, religious or scientific purposes.



ARTICLE III. MEMBERS

- (a) The members of this corporation shall be composed of those persons having an interest in the stated purposes of the corporation and a willingness to assist the corporation in carrying out those purposes.
- (b) Members of this corporation shall be admitted to membership by majority vote of the Board of Directors.
- (c) This corporation shall issue no stock. No part of the net earnings of this corporation shall inure to the benefit of or be distributable to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article.

ARTICLE IV. DURATION

The term of existence of the corporation is perpetual.
