Article III Purpose -

The specific purpose for which this corporation is organized is the following:

To produce original, contemporary and classical pieces of theatre and dance from all over the world. Utilizing the talents of South Florida's artists.

Article IV Manner of election of Directors -

Directors will first be appointed by Tanya Bravo and Paul Tei, Producing Artistic Directors and founders of Juggerknot theatre corporation. These first appointed directors will then elect following board members. In order for new board members to be elected they must first be pre approved by Tanya Bravo and Paul Tie. The purpose of the directors on the board is to raise money and promote interest in Juggerknot theatre corporation. Once a year the board of directors will be reviewed by Tanya Bravo and Paul Tei. If at any time the board of directors and board members do not meet their purpose they can be excused from their duties by Tanya Bravo and Paul Tei. The directors of the board do not have the power to relieve Tanya Bravo and Paul Tei from their positions of Producing Artistic Directors and founders of Juggerknot theatre corporation. Tanya Bravo and Paul Tei are not part of the board of directors.
