

ARTICLE I of the Articles of Incorporation of SEVEN NATIONS, INC. shall be amended to read as follows:

ARTICLE I. NAME

The name of the corporation shall be: SEVEN NATIONS, INC. The address of the principal office of this corporation shall be PO Box 693, Windermere, FLA. 3486-0693 and the mailing address of the corporation shall be the same.

ARTICLE IV of the Articles of Incorporation of SEVEN NATIONS, INC. shall be amended to read as follows:

ARTICLE IV. REGISTERED AGENT

The street address of the registered office of the corporation shall be 6238  
BLUE CLAY CT, ORLANDO FL and the name of the registered agent of the corporation at that address is Kirk McLeod. 32819

ARTICLE VI of the Articles of Incorporation of SEVEN NATIONS, INC. shall be amended to read as follows:
