"The name of the corporation is: Hurd, Hawkins, Meyers, Radosevich & Stevenson, Inc."

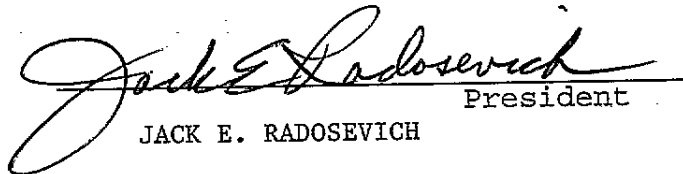
Article II is amended to provide:
